Change to Become a Member Group

You should note that at our AGM on 18 October 2010 CTC Exeter voted to become a Member Group. Prior to this it had operated as an Informal Group and both our Annual Return and Accounts were handled by CTC Devon.

As noted in the Return

CTC Devon was previously a District Association (DA) which included a number of Devon Groups (Exeter, Torbay, South Hams, Plymouth, North Devon and South Dartmoor).

Exeter will become a Member Group subsidiary to CTC Devon.

CTC Exeter members will take part in CTC Exeter and CTC Devon Events as well as being entitled to join rides organised by the other subsidiary groups.

Area of Coverage

We have informed CTC Devon that we will be adopting post code areas EX1-EX17 inclusive plus

EX24. This overlaps the CTC Devon area which encompasses the whole of Devon. This was discussed and accepted both at the most recent CTC Devon Committee Meeting (4 October 2011) and at the CTC Devon AGM (6 November 2011).

Accounts and Financial Return

CTC Exeter has also elected to make its 2010/11 Financial Return (Accounts) direct to HQ. As indicated above, in previous years (e.g. 2009/10) monies handled in the Exeter area were included in the CTC Devon Account.

We have thus also included a copy of our 'local' CTC Exeter Accounts for 2009/10 - the figures from which appear in the CTC Devon 2009/10 Account.

This years' (2010/11) CTC Exeter and draft CTC Devon Accounts show the separation of the two sets of accounts.

The 2010/11 CTC Exeter Accounts have been checked and signed off by an Honorary Auditor
